- FAMILIES:** Bookings can only be accepted for Family Parties or couples.
- DOGS:** You may bring your dog for a charge of £2.50 per day or £15.00 per week inc V.A.T. except in the 2009/2010 models. It must be ON A LEAD AT ALL TIMES ON THE CARAVAN PARK. Dogs must be exercised on the Cliff Top.
- DEPOSIT:** A minimum deposit of £100 per caravan per week or part week is required and reservations are made subject to caravan being vacant on receipt of your deposit. There is no refund of deposits made on reservations. Balance to be paid by cheque 14 days prior to arrival or cash on day of arrival.
- CHEQUES:** Cheques to be made payable to Crows Nest Caravan Park. Credit/Debit Cards are accepted with a £2 administration fee.
- KEYS:** Keys are available at Reception from 2pm to 6pm on the day of arrival. Please notify in advance of any arrival after 6pm or a later date. We reserve the right to relet if not informed. On departure, keys to be returned to Reception by 10.00am.
- EQUIPMENT:** All caravans are fully equipped with cutlery, crockery, cooking utensils and blankets. You are REQUIRED TO BRING sheets, pillow cases and table linen. Showers, WC, Colour T.V., fridge and microwave standard in all models. Central Heating as standard in 2008, 2009 and 2010 models.
- GAS & ELECTRIC:** Both are included in the price
- CAR PARKING:** There is parking for one car at each caravan on a hard standing. Extra cars must be left on the car park. NOT ON THE GRASS. Motorcycles and scooters are not allowed on the Caravan Park at any time.
- AMENITIES:** The bar, shop and fish shop may not be open at all times early and late season. There is a nominal entrance charge to the swimming pool, open Easter to the end of September.
